### Class 05:

### Class 29:

### Class 31:

Agricultural, garden and forestry products and aquaculture products; algae for human and animal nutrition; malt and unprocessed grain; fresh fruits and vegetables, fresh nuts and herbs; mushrooms; maize/corn; live animals, live animals for breeding purposes.

### Class 32:

Non-alcoholic beverages; non-alcoholic preparations for making beverages; beer and brewery products; flavoured carbonated beverages; nut- or soy-based beverages; juices; waters.

### Class 33:

Alcoholic beverages, except for beer; alcoholic preparations for making beverages; cider; mixed alcoholic beverages; spirits; wines.

Class 35:

Wholesale and retail, including online transactions, with respect to dietetic preparations and nutritional supplements; baby food; dietary supplements made of vitamins; beverages for babies; powered milk [baby food]; nutritional meal with milk additive for babies; food preparations for infants and young children; medicinal teas;

Wholesale and retail, including online transactions, with respect to meat and meat products; dairy products and their substitutes; milk; natural or artificial sausage skins; non-living fish, seafood and molluscs; edible oils and fats; soups and broths, meat extracts;

Transportation services, storage and trans-shipment [transport], limited in each case to processed fruits, mushrooms, vegetables, nuts and legumes; canned fruits and vegetables; bird's eggs and egg products; prepared insects and larvae; meat spreads; fish, seafood and mollusc spreads; cheese; jellies, jams, compotes, fruit and vegetable spreads; hummus;

Transportation services, storage and trans-shipment [transport], limited in each case to ice cream, frozen yoghurt, sorbet; coffee, tea, cocoa and their substitutes; table salt, condiments, spices, flavourings for beverages; processed grains and starches for foods and products made of them, baking preparations and yeast; sugar, natural sweeteners, sweet glazes and fillings and edible bee products; honey;

Transportation services, storage and trans-shipment [transport], limited in each case to non-alcoholic beverages; non-alcoholic preparations for making beverages; beer and brewery products; flavoured carbonated beverages; nut- or soy-based beverages; juices; waters;

Transportation services, storage and trans-shipment [transport], limited in each case to alcoholic beverages, except for beer; alcoholic preparations for making beverages; cider; mixed alcoholic beverages; spirits; wines;

Transportation services, storage and trans-shipment [transport], limited in each case to animal transport, live animals, live animals for breeding purposes.

Class 44:

Agriculture [animal husbandry]; raising animals; raising laying hens; raising piglets; raising cattle and other ruminants for milk and meat production.
